## Blue Prism University's "Expressions and Strings" promotion Terms and Conditions

These terms and conditions apply to the Blue Prism University "Express your Developer Knowledge" promotion (the "Competition").

1. **Promoter and prize provider**. The promoter of the prize draw and prize provider is Blue Prism Limited of 2 Cinnamon Park, Crab Lane, Fearnhead, Warrington, England, WA2 0XP, with registered company number 04260035 ("Blue Prism").

2. <u>The Competition</u>. The Competition shall be known as the Blue Prism University "Expressions and Strings" promotion.

3. <u>Eligibility</u>. NO PURCHASE NECESSARY. Entries completed after the Closing Time are not counted. Blue Prism will select the first 25 comments and create a group of eligible users who will be able to take part in the challenge. Blue Prism have the right to select a new user to join the group if one user decides to drop out. Blue Prism reserves the right to disqualify any entry at its absolute discretion. Blue Prism have the right to use any submissions as use cases or training in future Blue Prism University Courses.
