

Official Rules

Sponsored by Blue Prism® ("Sponsor")

No entry fee required. No purchase necessary.

To enter: In order to enter you need to:

- 1. Enroll and complete all 3 (three) of the following training courses *Introduction to Blue Prism Capture*, *Blue Prism Process Assessment Tool* and *Cyber Security in an automated world*, AND
- 2. Complete the Blue Prism University Adoption Survey make sure to include your name so that we can include you in the draw, AND
- 3. <u>Take a picture with the training completion/participation certificate</u> and post it on the community with the hashtag #sweetcertification from 15th February 2021 to 21st February 2021 by 11:59pm GMT ("Entry Period")

For your convenience, training certificates of completion and participation are available free of charge at Blue Prism University LMS (https://university.blueprism.com). Entrants are limited to one entry during the Entry Period and are expected to start and complete the learning within the Entry Period. Learning and/or course completions that started outside of the Entry Period will not be considered.

Prizes: There will be a drawing on 1st March 2021 and we will award total of 20 (twenty) winners – the first 10 (ten) will receive a certification voucher for any exam and the remaining 10 (ten) will receive a half price (50%) voucher redeemable against any exam.

Eligibility: The competition is open to anyone age 18 or older, who have an active email account and internet access as of the beginning of the promotion/contest period. Employees of Sponsor, their immediate family members and persons living in their same household, are not eligible to participate in the promotion/contest.

Participation in the promotion/contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and Regulations ("Official Rules").

No mechanically reproduced social media entries are allowed and any use of robotic, automatic, programmed or the like entry methods will void all such entries by such methods.

Prize Drawing: All promotion/contest name entries meeting the requirements of these Official Rules will be entered into the prize drawing to be held on 1st March 2021. The drawing will be conducted by Blue Prism's Global Head of Education Services whose decisions are final and binding. The winners will be selected at random from among all eligible entries received.

In the event of a dispute as to the identity of a winner, the winner will be deemed to be the person in whose name and email the community account was received. Entrants must have an eligible account on Blue Prism Community and LMS platform and must provide all information requested to be eligible to win. All entries must be received by the close of the Entry Period.
